The salary of the Chief Financial Officer (CFO) is determined through a study of the compensation packages of the CFOs of 5 schools similar size in terms of enrollment and resources. The study includes salary, benefits and other compensation along with the job responsibilities. The Head of School and Treasurer of the board determine the compensation of the CFO. The compensation package is elaborated in a contract between the CFO and the school.
