The Federation has elected to defer the application of Interpretation 48 in accordance with FASB Staff Position (FSP) FIN 48-3. This FSP defers the effective date of Interpretation 48 for nonpublic enterprises, such as the Federation, included within its scope to the annual financial statements for fiscal years beginning after December 15, 2008. The Federation will be required to adopt FIN 48 in its 2010 annual financial statements. Management is currently assessing the impact of FIN 48 on its financial position and results of operations and does not expect that the adoption of FIN 48 will have a material effect on its financial statements.
