All of the horses used in our program are rescued or donated. We provide these horses with the best care available, including regular veterinary, equine dental, and farrier care. Some of our horses also receive additional supplements, chiropractic care, acupuncture and physical therapy. Many of our horses would have been destroyed or neglected if not for the opportunity that we give them for a healthy and productive life. All of the horses work in the program, so these costs are not reported separately.

Square Peg Foundation works closely with other non-profits and educational institutions to provide volunteering opportunities and program services to their clients/students. These partnerships provide Square Peg Foundation with students from a variety of backgrounds and diagnosis, and allows our partner organizations to add a wonderful educational and recreational program to their suite of services and programs. These students are part of our regular adaptive horsemanship program, so costs are not reported separately.
