

IN FY 09, THE FOUNDATION RAISED \$68,000. THE FOUNDATION RAISES MONEY THROUGH COMMUNITY OUTREACH ACTIVITIES AND EVENTS SUCH AS THE ANNUAL SPRING WINE FEAST IN WASHINGTON, DC. ONE HUNDRED PERCENT OF ALL PROCEEDS RAISED ARE USED TO DIRECTLY SUPPORT PROGRAMS FOR PEOPLE WITH DISABILITIES.

SINCE ITS INCEPTION, THE SERVICESOURCE FOUNDATION ALLOCATED MORE THAN \$1 MILLION DOLLARS IN DIRECT SUPPORT OF PEOPLE WITH DISABILITIES. THE FOUNDATION FULLY FUNDED THE PURCHASE AND RENOVATION OF THE PRINCE WILLIAM NEIGHBORHOOD PLACE, A COMMUNITY-BASED HOME IN WHICH INDIVIDUALS LEARN DAILY LIVING SKILLS SUCH AS COOKING, SHOPPING, MINOR HOME MAINTENANCE AND COMPUTER TRAINING. THE FOUNDATION HAS ALSO FUNDED STATE-OF-THE-ART SENSORY PERCEPTION CENTERS AT SERVICESOURCES DAY SUPPORT PROGRAMS AND PURCHASED AN ACCESSIBLE LIFT VAN. MORE THAN 100 INDIVIDUALS WITH SEVERE DISABILITIES ARE SERVED IN THE DAY SUPPORT PROGRAMS.
