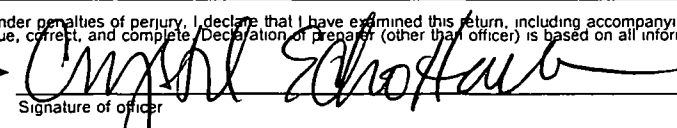

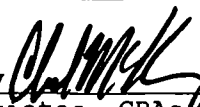

The Foundation's activities are focused on the development of model and evidence-based sports and wellness programs, primarily in the forms of golf and soccer, for Native American Youth.

The NB3 Foundation soccer program served 160 youth through its fall, spring and summer programming. This is approximately a 20% increase from the previous year.

Participating youth achieved over 200 minutes of physical activity per week through their engagement in our 24 weeks of soccer programming throughout the year.

The NB3 Foundation's Junior Arrowhead Gold Program served 45 youth through its regular school-year and summer programming. This is a 10% increase from the previous year. The Foundation delivered golf curricula focused on not only increasing the golf knowledge and skills of the participating youth but provided important lifeskills instruction and activities.
