THE 23RD CAC RECEIVED 497 REFERRALS OF SEVERE SEXUAL OR PHYSICAL ABUSE THROUGHOUT OUR FIVE COUNTY SERVICE AREA. ALL 497 CASES WERE REVIEWED BY THE CAC AND ITS MEMBERS OF THE MULTIDISCIPLINARY TEAM TO DETERMINE SERVICES NEEDED, AS WELL AS WHICH CASE WOULD BE REFERRED FOR PROSECUTION. OF THESE 497 CASES, 261 PROFESSIONAL FORENSIC INTERVIEWS WERE PERFORMED ON CHILDREN DEEMED APPROPRIATE; 460 MENTAL HEALTH SESSIONS WERE PERFORMED BY OUR OWN STAFF CLINICIAN AND 490 CLIENTS WERE OFFERED SERVICES THROUGH OUR VICTIMS ADVOCATE.
