BY PROVIDING SCHOOL SUPPLIES AT NO COST TO TEACHERS, SCHOOLHOUSE SUPPLIES LEVELS THE EDUCATIONAL PLAYING FIELD FOR ALL STUDENTS. THE FREE STORE FOR TEACHERS SERVES ALL 3,000 TEACHERS AND 46,000 STUDENTS IN THE PORTLAND PUBLIC SCHOOLS SYSTEM.

TOOLS FOR SCHOOLS. THE ORGANIZATION'S TOOLS FOR SCHOOLS PROGRAM CREATES DIRECT LINKS BETWEEN AREA BUSINESSES AND STUDENTS IN HIGH-NEED ELEMENTARY SCHOOLS. EACH YEAR, PARTICIPATING BUSINESSES PROVIDE BACK-TO-SCHOOL BACKPACKS FILLED WITH ESSENTIAL SUPPLIES FOR STUDENTS IN PORTLAND'S TITLE I SCHOOLS, WHERE MORE THAN 65% OF THE STUDENTS ARE ELIGIBLE FOR FEDERALLY FUNDED FREE OR REDUCED LUNCH. INCLUDING CONTRIBUTIONS, THE ORGANIZATION'S REVENUES FOR TOOLS FOR SCHOOLS TOTALED \$267,355. WITH EXPENSES OF \$181,631, THE PROGRAM GENERATED A NET SURPLUS OF \$85,724 FOR THE ORGANIZATION.

SCHOOLHOUSE SUPPLIES ONLINE IS AN INNOVATIVE WEB-BASED SUPPLY STORE THAT CHANGES HOW FAMILIES SHOP FOR BACK-TO-SCHOOL SUPPLIES. PARENTS CAN PURCHASE INDIVIDUALIZED "KITS" (DURING THE JUNE-AUGUST PERIOD) THAT MATCH THE SUPPLY LIST OF THEIR CHILD'S ASSIGNED CLASSROOM. 2008 MARKED THE ORGANIZATION'S THIRD YEAR OF SELLING SCHOOL SUPPLY KITS ONLINE, GENERATING A MODEST EARNED REVENUE STREAM AND PRESENTING DONATION OPPORTUNITIES TO A WIDER AUDIENCE. INCLUDING CONTRIBUTIONS, THE ORGANIZATION'S REVENUES FOR SCHOOLHOUSE SUPPLIES ONLINE TOTALED \$48,954. WITH EXPENSES OF \$33,878, THE PROGRAM GENERATED A NET SURPLUS OF \$15,076 FOR THE ORGANIZATION.

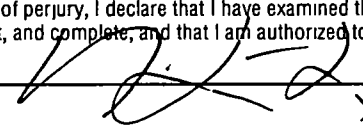
