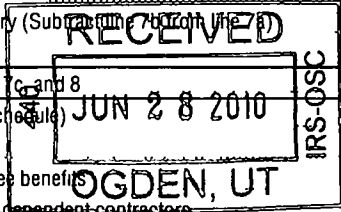



TO ADDRESS THE HOUSING NEEDS OF LOW AND MODERATE INCOME RESIDENTS IN THE GREATER ATTLEBORO AND TAUNTON AREA AND TO ENHANCE COMMUNITYWIDE AWARENESS, CONCERN AND ACTION REGARDING THE PROBLEMS OF THE LACK OF AFFORDABLE HOUSING AND PERSISTENT POVERTY; ALSO TO DEVELOP AFFORDABLE HOUSING FOR THE LOW AND MODERATE INCOME HOUSEHOLDS TO EITHER OWN OR RENT, AND TO PROVIDE OTHER RELATED HOUSING SERVICES.
