The Executive committee approved 9 grants during FY 2007 including support for projects at the Lower East Side Tenement Museum in the U.S. and the Gulag Museum at Perm-36 in Russia.

Regional Activities - networks of sites that collaborate to address common histories and their contemporary legacies and build capacity of emerging Sites of Conscience. In FY2007, the Coalition expanded its Regional Projects in Africa, Russia, South and Southeast Asia, and South America to include dozens of emerging memory initiatives and launched 4 joint citizen engagement projects.
