The College of Saint Elizabeth operates a college in the Catholic, liberal arts tradition. Founded in 1899 by the Sisters of Charity of Saint Elizabeth, the College of Saint Elizabeth is the oldest four-year liberal arts college for women in the State of New Jersey and one of the first Catholic colleges in the United States to award degrees to women. In 1903, the College bestowed its first baccalaureate degrees to a class of four women. Today with nearly 15,000 graduates, the College remains strong, with a growing enrollment and a vital purpose to provide a value-centered education that responds to today’s society’s needs while remaining true to its mission. The College offers 31 undergraduate degrees, including three combined bachelor/masters degrees. Among these 31 undergraduate degree programs, eight are coed undergraduate programs and offer classes in the evening and on weekends. Students can choose from 11 masters’ programs, of which Justice Studies is offered online. In 2007, the College established its first doctoral program in educational leadership. In addition, students have a choice of 25 graduate and undergraduate certificate programs, aimed at enhancing their professional skills and personal growth.
