There are three schools: the Undergraduate College, the School of Graduate Studies, and the School of Professional Studies. The Undergraduate College offers a number of majors and academic programs, awarding Bachelor of Arts, Bachelor of Fine Arts, and Bachelor of Science degrees. Each program offers an in-depth study of a particular subject area as well as a breadth of study in the liberal arts. The School of Graduate Studies offers graduate programs that award the Master of Business Administration, Master of Science in Business, Master of Arts, Master of Fine Arts, and the Master of Education degrees. The School of Professional Studies offers accelerated degree programs, certificates, and corporate training. The academic focus of the accelerated degree programs is on relevant and practical knowledge and techniques. Small class size and a seminar atmosphere compliment the learning experience.
