

Dock Acres purpose is to plan, establish, operate and maintain housing for retired persons, the elderly, handicapped or otherwise disadvantaged persons, to provide elderly persons, on a nonprofit basis, with housing facilities and services specially designed to meet the spiritual, physical, emotional, social, and psychological needs of aging, and contribute to their health, security, happiness and usefulness in longer living, and to engage in programs, designed to promote and encourage the development and improvement of facilities for housing of retired, aging, handicapped and disadvantaged persons. Dock Acres provided retirement housing and related services to elderly and retired persons through the operation of 174 residential living apartments, cottages and villas. The community provides healthcare services to these residents through a continuing care agreement that includes Hatfield Mennonite Home. Residents can receive benevolent care when their resources are not sufficient to cover the full cost of their care. Dock Acres also serves the broader community by hosting a health fair and providing educational seminars. The facility is made available at no charge to health service organizations providing support and education in the areas of macular degeneration and diabetes control. The facility also hosts seminars for pastors and those serving seniors in the broader community on meeting the needs of the elderly. It also serves spouses and family members of persons suffering from dementia by hosting a support group that is open to the public. The facility also serves the local community by serving as a polling place for elections.
