Mercy Hospital Foundation ("The Foundation") provided \$1,094,000 in funding in fiscal year 2009 (includes in-kind gifts of property and services) to Mercy Hospital Iowa City for facility improvements, medical equipment, patient comfort items and educational materials and programs. The new Hospice Unit, which received a majority of the funding, has served 146 patients and their families since its opening in April, 2009. The medical equipment serves the general population of the hospital. The patient comfort items, educational materials and programs are directed by hospital staff to the appropriate patients. In addition, the Foundation funded 30 scholarships of \$1,000 each for students entering the healthcare field and provided 41 scholarships for employees who are pursuing a degree in nursing at a total of \$18,000.
