ALL DONATIONS TO THE SCHOOL ARE REQUESTED TO BE PAID TO THE FOUNDATION AND ARE SOLICITED USING MAIL AND THE UNIVERSITY WEBSITE. THE FOUNDATION RECEIVED CONTRIBUTIONS FROM 2,505 DONORS IN THE FISCAL YEAR ENDING 6/30/2008 AND FROM 2,869 DONORS IN THE FISCAL YEAR ENDING 6/30/2009. DONATIONS ARE RECEIVED FROM A WIDE VARIETY OF PERSONS INCLUDING ALUMNAE OF THE UNIVERSITY, BUSINESS AND NON-BUSINESS RESIDENTS OF THE NORTH GEORGIA COMMUNITY, AND PERSONS/BUSINESSES GENERALLY INTERESTED IN SUPPORTING THE SCHOOLS ACADEMIC PROGRAMS. A LISTING OF SOME OF THE DONORS MAY BE FOUND ON THE UNIVERSITY WEBSITE. THE BOARD OF TRUSTEES OF THE FOUNDATION CONSISTS OF UNIVERSITY ALUMNAE AND MEMBERS OF THE BUSINESS COMMUNITY IN THE STATE OF GEORGIA. BASED ON THE ABOVE FACTS AND CIRCUMSTANCES AND THE FACT THAT THE FOUNDATION'S CURRENT PUBLIC SUPPORT TEST IS 22.31%, THE FOUNDATION BELIEVES THAT IT MEETS THE 10% FACTS AND CIRCUMSTANCE TEST AND, THEREFORE, CONTINUES TO BE A PUBLIC CHARITY.
