|    | The Haven continues to offer residential drug and alcohol treatment services to homeless and indigent women. For this service, The Haven's funding comes from other non-profit organizations who receive funding from the federal and state governments. The Haven opened a new facility, Casa de Palmas, in July 2009, for women who are able to pay for their services. Any surplus earnings the Haven may acquire are retained by the organization for its future provision of programs and services and are not owned by nor distributed to individuals or stake-holders. The Haven (including Casa de Palmas) served 224 women during the '08-'09 fiscal year and approximately 200 children stayed with their mothers while their mothers received treatment services. The Haven does not provide services for children. As with all non-profit organizations, capacity building is an ongoing problem for The Haven. The organization relies on external funding which includes government funds, grants from charitable foundations, direct donations and self-pay clientele to maintain operations. Changes in these funding sources can greatly impact the reliability or predictability with which The Haven can hire and retain staff, sustain facilities, or create much needed programs. The Haven is governed by a nonpaid Board of Directors. The board consists of members of the community who are committed to The Haven's mission and vision. As a non-profit, The Haven relies upon volunteers to provide assistance for services that cannot be funded. |
