The Freestore Foodbank (FSFB) is one of Ohio's largest food banks, serving more than 160,000 low-income people in 20 counties throughout Ohio, Kentucky and Indiana. Over 150 manufacturers and retailers donate food and other products such as household and personal hygiene items that are usable but cannot be sold for a variety of reasons. Numerous food drives conducted by organizations in the community also contribute to FSFB's food supply. Annually, FSFB receives about 10 million pounds of food and redistributes it to those in need. Collaborating with the Freestore Foodbank in distributing emergency food and other social services are approximately 400 non profit member agencies, which operate food pantries, shelters, soup kitchens, daycare, senior and community centers and other social services agencies to assist those in need in their own neighborhoods. We use food to strengthen our community by creating positive solutions for stability and self-reliance.

The Freestore Foodbank Client Services Division works to meet the needs of our community's most vulnerable citizens including the homeless, unemployed, working poor and families in crisis. In the most recent fiscal year, the FSFB Food Room distributed 1.7 million pounds of food to 19,800 households. Those who seek assistance from the Freestore, located in the Over-the-Rhine neighborhood, come from many neighborhoods in and around Cincinnati. In addition to providing emergency food services, FSFB has many programs and services aimed at furthering self-reliance including emergency clothing, housing services, Medicaid outreach, and others. Addressing hunger allows us to have conversations on other issues affecting individuals, families and communities.
