

The organization had 2,144 interactions with low-income uninsured persons resulting in 703 referrals for safety-net health care services, and 593 referrals for other social services. The organization accepted case management referrals from partner agencies for 177 new patient, and provided case management services to a total of 227 low-income uninsured patients with chronic diseases such as diabetes, hypertension, chronic obstructive pulmonary disease, asthma, and heart disease.
