CONVALESCENT HOSPITAL FOR CHILDREN AND ORPHAN ASYLUM ("CHCOA") WAS FORMED FOR THE SOLE PURPOSE OF PROVIDING FINANCIAL SUPPORT TO THE CONVALESCENT HOSPITAL FOR CHILDREN ("CHC"), AN OHIO NOT-FOR-PROFIT PEDIATRIC HOSPITAL. SUCH FINANCIAL SUPPORT IS PROVIDED FROM EXPENDABLE INCOME RECEIVED FROM INVESTMENTS OF RESTRICTED AND UNRESTRICTED FUNDS. IT IS THE POLICY OF CHCOA TO INVEST SUCH ASSETS, THEREBY INCREASING FUND PRINCIPAL AND ENHANCING FUTURE EXPENDABLE INCOME DURING CHCOA'S FISCAL YEAR OF JULY 1, 2008 THROUGH JUNE 30, 2009 (THE YEAR COVERED BY THIS RETURN). CHCOA PROVIDED FINANCIAL SUPPORT AMOUNTING TO \$1,549,034 TO CHC. THESE FUNDS WERE UTILIZED BY CHC TO SUPPORT THE OPERATING COSTS OF ITS PEDIATRIC REHABILITATION PROGRAM, ITS DISABILITY SERVICES PROGRAM, ITS ADOLESCENT PSYCHIATRIC SERVICES PROGRAM, THE SPECIAL NEEDS CHILDREN PROGRAM, ADHD INTAKE AND TRIAGE PROGRAM AND TO SUPPORT THE GENERAL OPERATIONS OF CHC BECAUSE OF THE DIRECT FINANCIAL SUPPORT OF CHCOA TO CHC, CHC HAS BEEN CONSISTENTLY ABLE TO REINVEST IN ITS PROGRAMS AND MAINTAINS A NATIONAL POSITION AS ONE OF THE LOWEST COST PEDIATRIC HEALTH CARE PROVIDERS IN THE NATION. IN MAY 2006, CHCOA'S BOARD OF TRUSTEES MADE A REVOCABLE \$5 MILLION PLEDGE OF UNRESTRICTED PRINCIPAL TO CHILDREN'S HOSPITAL MEDICAL CENTER ("CHMC") TO PROVIDE CAPITAL AND OPERATING SUPPORT OF A RESEARCH AND CLINICAL INITIATIVE KNOWN AS "CHANGE THE OUTCOME". THE PLEDGE IS FOR \$1 MILLION A YEAR FOR FIVE YEARS COMMENCING IN FISCAL 2007
