AS CREATIVE CAPITAL INVESTS IN MULTI-YEAR RELATIONSHIPS WITH GRANTEEES, FUNDS WERE ALSO GIVEN TO THOSE WHO WERE AWARDED GRANTS IN PAST YEARS. FUNDS USED IN THIS CATEGORY REPRESENT DIRECT GRANTS TO ARTISTS, IN ADDITION TO THE COSTS ASSOCIATED WITH GRANTMAKING, INCLUDING THE SELECTION OF GRANTEEES AND THE ADMINISTRATION OF GRANT FUNDS. 40 GRANTS WERE ALSO AWARDED THROUGH THE MULTI-ARTS PRODUCTION FUND AND 27 THROUGH THE ARTS WRITERS PROGRAM.
