THE ORGANIZATION'S FUNDS WERE USED TO SUPPORT EXHIBITS AND PROGRAMMING AT THE FOUNDATION'S TWO MUSEUMS. THIS INCLUDES ARTIFACT ACQUISITION AND CONSERVATION, AS WELL AS SPECIAL EXHIBITIONS. DURING THIS YEAR, 24 ARTIFACTS WERE ADDED TO THE FOUNDATION'S COLLECTION, MOST NOTABLY A JULY 18, 1776 PRINTED COPY OF THE DECLARATION OF INDEPENDENCE. FUNDING ALSO SUPPORTED ON-SITE EVENTS AND PROGRAMS, A LECTURE SERIES WAS HELD IN CONJUNCTION WITH THE SPECIAL EXHIBITION, JAMESTOWN AND BERMUDA, VIRGINIA COMPANY COLONIES, AND A LECTURE SERIES DURING FEBRUARY IN CONJUNCTION WITH BLACK HISTORY MONTH. FUNDING ALSO SUPPORTED THE SUMMER TEACHER INSTITUTE, WHICH IS A WEEKLONG EDUCATION PROGRAM FOR 24 VIRGINIA TEACHERS THAT INCLUDES HISTORICAL CONTENT, INSTRUCTIONAL TECHNIQUES, AND AN OPPORTUNITY TO PRACTICE WHAT THEY ARE LEARNING AS THEY WORK IN COSTUME WITH A MENTOR AT ONE OF THE MUSEUMS. HANDS-ON OUTREACH EDUCATION PROGRAMS WERE PRESENTED TO APPROXIMATELY 19,000 ADDITIONAL STUDENTS IN THEIR VIRGINIA CLASSROOMS, AND APPROXIMATELY 2,000 STUDENTS PARTICIPATED IN THE ELEMENTARY SCHOOL SCHOLARSHIP PROGRAM WHICH INCLUDES AN OUTREACH PROGRAM AND ON-SITE FIELD TRIP TO JAMESTOWN SETTLEMENT. ADDITIONAL RESOURCES ARE BEING USED TO DEVELOP NEW EDUCATIONAL MATERIALS FOR THE FOUNDATION'S WEB SITE. RESEARCH MATERIALS, AUCTION HOUSE CATALOGUES, MEETING EXPENSES FOR THE ANNUAL MUSEUMS & PROGRAMS ADVISORY COUNCIL, VOLUNTEER RECRUITMENT AND RETENTION, AND GRAPHIC RIGHT PURCHASES TO SUPPORT THE GALLERIES WERE OTHER AREAS IN WHICH FUNDING ASSISTED WITH THE PROGRAMMING AND EXHIBITS AT BOTH MUSEUMS.

Funds of \$4,800 and \$2,800 were withdrawn from the fund for programs in 2009 and 2008, respectively. The General Endowment fund was established to provide cash flow for Jamestown Yorktown Foundation, Inc. and Jamestown-Yorktown Foundation. The primary investment objective of the General Endowment fund is to preserve and protect the assets by focusing on conservation of principal and long-term growth of capital and income. This objective is generally attained by investing in a portfolio of high quality securities. Expenditures from the fund are based upon a 5% spending plan using a three-year average market value. Funds of \$195,000 and \$181,500 were withdrawn from the fund in 2009 and 2008, respectively. Donor Restricted Endowments At June 30, 2009, the Foundation's donor restricted endowment funds consist of 9 individual funds established for a variety of purposes. In addition, the Foundation has established the Education Programs Fund to receive permanently restricted donor gifts to support educational programs including on-site educational programs, statewide and national outreach programming and future permanent and special exhibits. The investment policy for donor restricted endowment funds is to preserve the purchasing power of the assets and to ensure that the present value of the invested funds grows at a rate that will exceed inflation, preserve principal and generate maximum total return consistent with acceptable levels of risk. This objective is currently attained by investing in a portfolio of high quality securities.
