Tree Planting: Activities associated with planting and maintaining trees with individuals, neighborhood groups and other cooperators.

The Tree Planting department planted over 1,280 trees during the fiscal year through various programs, including over 500 trees planted through the Community Tree Planting program, our primary volunteer engagement vehicle. It also includes over 420 trees planted through our grant from the District Department of the Environment for residential property dwellers, including the Tree Rebate program, the RiverSmart Homes program, and the TreeScape Design Workshops. Almost 300 American elms were planted on streets identified as historic elm corridors throughout the District under our Elm Restoration program.

Casey Tree Farm: Now undergoing stabilization, the Farm will be used to extend Casey Trees' existing programs to a broader DC-metro constituency inclusive of the Chesapeake Bay Region.

Education: Activities associated with developing, implementing and evaluating education and training programs such as: Homeowner Design Workshop, Citizen Forester, Tree Walks, High School Internship and others.

The Education department undertook activities associated with developing, implementing and evaluating education and training programs such as our adult education classes and tree walks for Citizen Foresters and volunteers, and others. 1,008 volunteers planted trees and 170 volunteers watered, mulched and maintained trees. We hosted 40 educational trainings and classes in which we had 762 students. The department also leads the 8-week summer employment program. Each summer
