The University provides over 2800 students on six campus locations a higher education that fosters critical thinking, effective communication, spiritual growth, and personal, professional and cultural development. The University offers the following degrees Associate of Arts, Associate of Science in Computer Science, Bachelor of Arts, Bachelor of Science, Bachelor of Science in Education, Bachelor of Science in Nursing, Master of Arts in Education, Masters in Business Administration (MBA), Masters of Arts in Counseling and Human Development, Masters of Arts in Theology, Doctor of Physical Therapy. Walsh University is accredited by the following North Central Association/Higher Learning Commission, National League for Nursing Accrediting Commission, Ohio Department of Education, Ohio Board of Counseling & Social Work, American Physical Therapy Association, The Commission on Accreditation in Physical Therapy Education, Council for Accreditation of Counseling and Related Educational Programs, National Council for Accreditation of Teacher Education. The Walsh library is a member of OhioLINK, and all library resources are searchable through the Internet. Within the library students have full access to 139,465 volumes, 340 paper subscriptions, 37,077 electronic periodicals, 171,662 electronic books, 227 electronic databases and 5,763 audio visual titles (includes online educational videos). The Walsh experience blends excellent academics with co-curricular programming and services designed to address the diverse needs of its students. Integral to this effort is the student affairs team comprised of professionals committed to the holistic development of students, firmly believing that all students have the potential to become valuable assets to our world community. To that end, these individuals represent the Christian values espoused in the University mission statement, enflleshed by our care and concern for students, relationships, and the community. Walsh University provides over 1000 students with housing and dining services. Several of the nine residence halls are newly constructed and offer apartment-style and suite-style living. Dining service facilities include the Scherf Dining Hall, the Betzler Grille, the Cavalier Cafe and the C-Store offering various meal plan selections and dining innovations. Walsh University's athletic program offers 19 different men's and women's athletic teams. Walsh is a member of the National Association of Intercollegiate Athletics (NAIA) and competes in the 14 member American Mideast Conference (AMC) and the Mid-States Football Association. The Walsh Cavaliers enjoy a winning tradition, having won NAIA national championship in both men's and women's basketball, a national championship in men's hammer throw, and competing on the national stage for championships in men's and women's tennis, men's and women's golf, softball, baseball, men's and women's cross country and track, men's soccer, football, and volleyball. Walsh's total sports programs regularly vie for the AMC All Sports Award and last year finished first in the women's competition and third in the men's. Fiscal year 2009 saw the opening of the Father Matthew Herttna Counseling Center. With more than 100 men and women pursuing a career in Counseling and Human Development (CHD), the Father Matthew Herttna Counseling Center was developed to serve as an adjunct to off campus clinical experiences required of students. This new campus resource will enable CHD students to acquire more practicum experience under the direct supervision of experienced faculty, better preparing them for professional success. Clinical services at the new Walsh clinic will provide much needed counseling to lower-income, uninsured adults, children and families from the local community.

Several firms participated and Fred Olivier Construction Company came in as the lowest bidder on the combined projects and was awarded the contracts accordingly. Fred Olivier Construction Company also served as the construction manager on the renovation of the University's physical education building (completed in FY07) and the Towers II Residence Hall (completed in FY08). In FY08 Fred Olivier Construction Company was also awarded the construction contracts for the Campus Sport Complex and the Community Counseling Clinic, both additions to existing buildings. Fred Olivier was awarded these projects as a result of the "economies of scale" that would be recognized by the University, due to Fred Olivier's knowledge of the existing buildings and savings on architectural fees. The selection was also based on the company's qualifications and strong reputation. It was also determined that Fred Olivier Construction Company, as construction manager, would be responsible for utilizing a competitive bid process in the selection of all subcontractors.
