GAMA FOUNDATION DISTRIBUTION POLICY

1. **Purpose** The purpose of this policy is to establish the parameters for distributions from the GAMA Foundation with the following goals:

- (a) Provide a predictable system of calculating maximum distribution limitations based upon long term income and appreciation expectations, which system will moderate short term market value fluctuations in the fund.
- (b) Provide for a reasonable retainage of income to provide for internal growth of the fund.

These distribution restrictions would not apply to funds in accounts which anticipate and permit the expenditure of both principal and income (including net appreciation) in that account such as capital project accounts (collectively, the "Unrestricted Accounts")

2. **Maximum Annual Distribution**

General Policy. Except for emergency distributions and distributions from Unrestricted Accounts, the annual aggregate distributions from the fund to the school for any school year will not exceed the sum of:

- 1. The maximum distribution is to be 5% of the average of the sum of market values of the fund on
 - (a) the last day of the quarter ending December 31st.
 - (b) the last day of each of the 11 calendar quarters before that December 31st;plus
- 2. The aggregate available-but-undistributed amounts from the previous three years.

Restricted Accounts. For accounts that limit distributions to income or net appreciation in the account, no distribution may be made from that account if the balance in that account after the distribution would reduce the balance below the corpus amount.
