Their mission is to expand Akron's rich legacy in material science, and to pioneer the next generation of life-enhancing and life-saving biomedical innovations for the 21st Century.

Medical Imaging - Northeast Ohio is well known for its medical imaging industry. BioEnterprise is in the process of catalyzing this cluster of business. This cluster would improve the economic development in the distressed area of Northeast Ohio. BioEnterprise has participated in 73 meetings during the fiscal year to develop the Medical Imaging Cluster.

Medical Manufacturing - Northeast Ohio has a manufacturing base, a lot in the auto industry. We are in the process of assisting in the marketing and education of our region's traditional manufacturers on the opportunities in medical manufacturing. BioEnterprise participated in an event for the region's manufacturers to educate them on how to enter the medical industry. There were 170 attendees.

TiE Ohio - BioEnterprise was instrumental during the fiscal year in the formation of this chapter of immigrant entrepreneurs in Northeast Ohio to access talent, ideas and enterprise to improve economic development in the region. The organization had 126 members at the end of the fiscal year.

BioEnterprise presented the following events for the bioscience cluster to improve its efficiency, knowledge and economic development: Private Equity Event (198 attendees), Consultants Event (121 attendees), Government Funding Event (72 attendees) and CEO Event (61 attendees).
