	Elmhurst Memorial Hospital is a not-for-profit healthcare organization that provides acute and nonacute inpatient and outpatient care to residents of Eastern DuPage and Western Cook Counties. Founded in 1926, Elmhurst Memorial Hospital has expanded its services and has several conveniently located Care Centers to better serve its patients, their families and numerous communities. In fiscal year 2009, Elmhurst Memorial treated more than 16,000 inpatients and totaled more than 391,000 outpatient visits. There were more than 43,000 visits to the Emergency Department and more than 22,000 visits to two Immediate Center Centers. The organization also provided more than \$76 million in community benefits, which include a generous financial assistance policy that exceeds the standards recommended by the Illinois Hospital Association, charity care and more than 200 community education programs and events. In addition, Elmhurst Memorial Hospital continues to make progress on the construction of a fully integrated medical campus that will change the perception of what a hospital can be. Located at the corner of York and Roosevelt roads in Elmhurst and scheduled to open in 2011, the campus is situated on a highly accessible 50-acre site and will include an acute care hospital with all private rooms, outpatient services in the existing Elmhurst Memorial Center for Health and a variety of physician offices in proposed new medical office buildings.

	The Elmhurst Memorial Hospital Foundation was established in 1980 as the official fundraising and gift receiving arm of Elmhurst Memorial Healthcare. The Foundation encourages and receives contributions that are used to enhance the delivery of high quality, comprehensive healthcare services for those who live and work in the communities served by Elmhurst Memorial Healthcare. The Foundation accomplishes this through fundraising events, such as the annual Autumn Affair, and programs, such as The Grateful Patient program, which was established by the Foundation as a way for patients to show their thanks and appreciation for the care they received at Elmhurst Memorial Healthcare by making a donation. Now, with the new integrated medical campus scheduled to open in 2011, the Foundation has set out to build private philanthropic support for the project. To reach its goal, the Foundation launched Exceptional Past, Extraordinary Future Campaign for the New Elmhurst Memorial Hospital - the most ambitious fundraising initiative in the organization's history.

	Elmhurst Memorial Home Health provides a complete range of services, combining technical expertise and compassionate care for patients of all ages and medical needs. It has made it a priority to provide patients with high quality, compassionate care - services that make a difference in the lives of patients. Elmhurst Memorial Home Health is a state licensed, Medicare-certified agency that is accredited by The Joint Commission. It is also a member of the Illinois Home Care Council and National Association for Home Care. Through the Hospice program, appropriate care and support allows patients to live the last phase of life fully, with dignity and freedom from pain or discomfort, in the presence of familiar persons and surroundings. An interdisciplinary team approach is used to help terminally ill patients and their families face physical, emotional, psychological, social and spiritual aspects of their lives and the patient's death, together in an atmosphere of support and acceptance. In fiscal year 2009, Elmhurst Memorial Home Health admitted more than 1,800 patients while Hospice admitted more than 300 patients with an average of nearly 50 days from admission to death.
