Programs that provide prenatal care and family planning services to teens and young adults

Rush Adolescent Family Center is one of the oldest, most respected prenatal and family planning clinics for teens. The Prenatal Care Program provides a full range of prenatal care with prenatal counseling and education programs. The Family Planning Program provides confidential gynecological care, contraceptive and counseling services. The Community Education Program provides pregnancy prevention, family life education and reproductive health education to teens and preteens attending Chicago area schools and agencies.

Holy Family New Beginnings Program

The New Beginnings Program is a prenatal care program designed to provide the best possible environment for babies to be born healthy. A bi-lingual staff provide counseling and emotional support as well as exams, lab testing nutritional counseling, classes in childbirth, infant care, parenting, siblings and assistance in filing for benefits.

Programs to guide children in group housing situations to make healthy choices

Mercy Works Program at Mercy Home for Boys and Girls

The Mercy Works program offers an opportunity for volunteers to gain professional experience in a year long program which provides weekly community nights and periodic retreats for the children at Mercy Home. It builds community and an additional source of motivation and spiritual grounding.

SOS Childrens Villages

SOS Childrens Villages provides a viable alternative to traditional foster care. Children stay with their biological siblings in private homes. A full-time, professionally trained foster parent lives with them and the whole Village gives them support, compassion and strength.

Graduate Student Tuition Grants at Jane Addams School of Social Work, University of Illinois at Chicago

Graduate Students at the Jane Addams School of Social Work are given tuition grants when their internships relate to the purposes of the Chicago Foundlings Home. Currently four students are receiving grants: Two are at the Adolescent Family Center at Rush, one is working with young, pregnant high school girls and one is in a program for teen girls in the Juvenile Court system.

The Chicago Foundlings Home is legally required to preserve records of all adoptions (records since 1872) and respond to all queries from persons legally allowed to receive information.

Report Not Filed by Due Date

On February 14, I sent an Application for Extension of Time to File an Exempt Organization Return. It was denied.

In the crisis of my husband's terminal illness, I apparently sent the unsigned file copy rather than the one I had signed.

I have just received (May 14) the signed copy of the audit from Deloitte and Touche and am sending the report on May 14.

I hope you will take the circumstances into account for the late filing of this 990 report.
