Tobacco Control Reduce smoking rates and reduce public exposure to secondhand smoke Illinois "Smoke-Free" legislation was passed, and took effect January 1, 2008. Volunteers contacted state legislators to encourage their support of Smoke-Free legislation and oppose all efforts to have exemptions for casino's or private clubs from the smoke-free law. Federal lawmakers were asked to support a tobacco tax to fund children's health insurance program. We implement one on one and group tobacco cessation counseling through our Courage to Quit and Healthy Lungs Initiative programs
