Literacy Chicago is on course to establish a One to One student teacher ratio with many tutors volunteering their expertise and time because of their passion to eradicate illiteracy

Through classes in basic reading, GED preparation and English as a Second Language, Literacy Chicago served about 1200 adult learners.
