The Early Childhood Education Program is a child development program, serving 3 to 5 year old children that promotes positive development and prepares children for future success in school. A mixture of creative programming helps children develop skills and confidence, as well as find an enthusiasm for learning that is essential for future growth and success. Experiences in language, literacy, computers, math, science, music and art, nutrition and cooking, and outdoor play are provided. On-site special events and field trips occur regularly. The Creative Curriculum is utilized with a Project Approach and individualization for all children, including support for children with special needs. Nearly 90% of programming is full-day and year-long, with traditional Half-Day Head Start model also offered.

4b (Code:) (Expenses \$ 2,361,499. including grants of \$) (Revenue \$)
The Infant/Toddler Development Program provides quality, full-day, developmentally appropriate care for children, ages 6 weeks to 3 years, in a center-based setting. The program focuses on providing a safe and stimulating environment for young children to foster their social, emotional, cognitive, language and physical development. An emphasis is placed on being responsive to the child's natural cues, providing continuity of care, and building strong and consistent relationships between children, parents and staff. The Creative Curriculum is utilized with the Learning Basket Approach as an enhancement.

4c (Code:) (Expenses \$ 741,918. including grants of \$) (Revenue \$)
The School Age Program serves children ages 6-12, offering effective and comprehensive programming for children from kindergarten through the 6th grade. Choice time is built into the day allowing children to engage in a wide array of age-appropriate activities. Options include major areas that foster development in school age children: fine arts, literature, computers, math and science, games and sports. Long-term projects, cultural exploration, and leadership development are included. Highlights include an annual awards program and camping trips.
