Community Services Foundation (hereinafter "CSF") supports the two organizations listed on Schedule A, Line 11h. Its Articles of Incorporation name both listed supported organizations, and Article 4 of the Articles, being the purposes clause, currently in effect, is attached.

In the 2008 tax year, CSF granted to Charleston Transitional Facility, the supported organization, \$208,414.

In the 2008 tax year, CSF granted to Southwest Community Services, Inc., the supported organization, \$173,901.

In the 2008 tax year, CSF granted to Southwest Community Services, Inc., the supported organization, \$9,476.

Total grants and contributions to the agencies, in cash, was \$391,791.

In addition, CSF owns, through its development or its purchases, twenty-two residential facilities and four day treatment program facilities which are leased by CSF to the supported organizations at market rates or less. All of the properties or facilities are exclusively used by the supported organizations

No other organizations were supported by CSF, and the activities of CSF have been exclusively devoted to the named supported organizations.

In response to Schedule A, Part I, Line f - No written determination from the IRS that the organization is a Type 3 supporting organization can be found. The organization has consistently reported that it is a supporting organization. In the original determination letter, dated July 30, 1990, the letter determined the organization was described in 509(a)(i) and 170(b)(1)(A)(vi).

ATTACHMENT TO ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF COMMUNITY SERVICES FOUNDATION

ARTICLE 4:

The goal of Community Services Foundation is to promote the support, care and comfort of mentally disabled persons. To accomplish this goal, the corporation shall provide support and assistance to the mentally disabled and to tax-exempt entities providing services to the mentally disabled. The support and assistance to mentally disabled shall be provided to Southwest Community Services, Inc. and Charleston Transitional Facility, which are Illinois not-for-profit corporations qualified under Internal Revenue Code 501(c)(3).

The general purpose for which this corporation is formed is to operate exclusively for such charitable and educational purposes as will qualify it as an exempt corporation under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax law, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that code.

To meet its goals, the corporation shall have all of the general powers provided under the Illinois General Not-For-Profit Corporation Act of 1986, including the power to acquire, sell, and lease real and personal property.

This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation nor shall it participate or intervene (by publication or description of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Revenue law).

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

Upon the dissolution or winding up of this corporation, its assets remaining, after payment or provision for payment of all debts and liabilities of the corporation, shall be distributed to Southwest Community Services, Inc. and Charleston Transitional Facility, or if such

corporations shall not be in existence, then to a non-profit fund, foundation, or corporation which is operated and organized exclusively for religious, charitable or educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent Federal tax laws.
