To receive and maintain a fund or funds and to use and apply and use said funds exclusively for charitable, educational and scientific purposes and in particular, for the benefit, improvement and welfare of Marcus Daly Memorial Hospital, and its patrons by providing funds for buildings, equipment, special programs, furnishings and other items useful or beneficial to the operations of Marcus Daly Memorial Hospital. The Foundation is dedicated to ensuring that Marcus Daly Memorial Hospital has the best facilities and services for the residents of Ravalli County now and in the future. In the furtherance of this goal the Daly Hospital Foundation was able to contribute \$43,100 towards the construction of a new state-of-the-art Emergency Department. \$50,000 was contributed to the Hospital to support the construction of a new Rehabilitation Therapy building. The chemotherapy department was gifted \$7,359 to provide patients with new chemotherapy delivery pumps. The Foundation further advanced its goal of education and involvement by conducting a fundraising drive this past winter which focused its efforts towards the Hospital employees. The 1st and 10 campaign succeeded in raising an accumulated total of cash and pledges in the amount of \$149,000. These funds will be used to support future capital projects at the Hospital.
