IN THAT SAME TIME, 24,409 MEALS WERE SERVED, 1,425 SHOWERS WERE TAKEN, 1,738 ATTENDED CLASSES OR SUPPORT GROUPS, AND 8,701 PHONE CALLS WERE MADE ON A PHONE THAT IS AVAILABLE FOR HOUSING, EMPLOYMENT, AND MEDICAL CALLS BY THE HOMELESS.
