Community-Based programs offer children and their families a wide continuum of education, intensive counseling, crisis intervention, screening, concrete support, advocacy, respite and mentoring all within the family's community. Children are ages 0 - 21 years old. The goal of Community-Based services is to strengthen families through prevention, early intervention and treatment services. Children's Home has been one of the area's earliest pioneers in providing home-based family services in Illinois. Last year, 2,189 children received care. For youth that were homeless, 95% were in a stable, safe living arrangements when they completed their programming. For at-risk parents in the Good Beginnings program, 94% were able to provide stability and medical care for their children.

Kiefer School is an NCA-accredited, ISBE-approved private school for children and youth ages 3-21 years old who are experiencing special learning problems coupled with emotional and/or behavioral disturbances. Students typically have primary handicapping conditions of emotional, learning or cognitive disability, autism, other health impairments or traumatic brain injury. Educational placement occurs at no cost to parents. Students receive special education day treatment by multi-certified teachers and teaching assistants, speech and language therapy, occupational therapy, individual, group and family therapy, nursing care and job coaching services. Consultation services are available through child psychiatrists. Student to teacher ratio is 4:1. Last year, 194 youth were provided with 23,169 days of service. Parents report a satisfaction rate of 81%. Students demonstrated a 63% improvement in their academic functioning.

Residential treatment, Group Homes and Transitional Living provide 24-hour care for children ages 8 - 21 years old whose emotional, behavioral, sexual or social dysfunction requires highly structured living. Children suffer from aggressive behavior, depression and other psychiatric issues, impaired interpersonal relationships, physical, emotional and/or sexual abuse, environmental deprivation, sexual perpetration and family dysfunction. Treatment for the youth includes individual, group and family counseling, medical/psychiatric assessment and treatment, activity and educational programming. During the year, 159 youth received 22,858 days of care. For the children in Residential and Group Home care, 72% improved in their clinical functioning and 79% of families were satisfied with the services received. For those older youth in Transitional Living, 81% remained in stable living and did not require psychiatric hospitalization or enter the juvenile justice system.
