VARIOUS FUNDS BENEFITING ACLC WERE MADE DURING THE YEAR. THIS INCLUDED FUNDS FOR TECHNOLOGY, MUSIC PROGRAM, COUNSELING PROGRAM, FUTURE LEADERS INSTITUTE PROGRAM, ULTIMATE FRISBEE TEAM AND THE ANNUAL YEARBOOK.
