AT THE BEGINNING OF THEIR STAY, CLIENTS TAKE PART IN A COMPREHENSIVE, EMPATHETIC PROCESS TO ADDRESS AND IDENTIFY THE UNIQUE BARRIERS TO OBTAINING SUSTAINABLE HOUSING.
