The Foundation disbursed 48% of their total expenses for university programs. This represents funding for general operational support of university departments and colleges. This includes funding for department advancement funds that are used to support projects and activities not supported by state funding. The general number impacted by that type of program is 40 administrative units on campus and 850 administrative and operational support staff.

Student scholarships and awards is the second largest program service offered by the Foundation. \$1,489,467 was awarded to students this past year. This equates to 34% of total expenses. Funding comes from restricted and unrestricted funds. The number of scholarship recipients is over 1,000 students.

The third largest area of Foundation funding support is for the alumni office. The alumni office coordinates events on campus and in other cities across the United States for alumni gatherings. 54 events were held this fiscal year with 5,498 alumni in attendance.
