The facility provides outreach services such as physical therapy, respiratory therapy, and flu vaccination clinics to other employers in the area as well. For the fiscal year ended June 30, 2009 the medical center provided as part of its mission 760 acute days, 877 swing bed days, and 16,372 clinic visits. For fiscal year 2009, the amount of charity care based on the amount of charges foregone, based on established rates, was \$70,899
