	Avera Queen of Peace's mission is to provide Healthcare services to Mitchell, SD residents and surrounding area. They provide acute care and long-term healthcare services, of which there were 10,882 acute patient days, 3,022 swing-bed patient days, 1,192 nursery patient days, and 42,194 nursing home resident days. The breakout of these statistics per facility is as follows: Avera Queen of Peace Hospital: 10,205 Acute patient days, 2,289 Swing-bed patient days, 1,292 Newborn patient days; Avera Brady Health and Rehabilitation: 30,247 Long-term care resident days, 9,196 Assisted living days, 2,751 Independent living days; Avera Wescota Memorial Medical Center (CAH): 408 Acute patient days, 458 Swing-bed patient days; Avera De Smet Memorial Hospital: 269 Acute patient days, 275 Swing-bed patient days. Avera Queen of Peace maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges foregone for services and supplies furnished under its charity care policy and equivalent service statistics. The amount of charges foregone, based on established rates, were \$1,506,410. Avera Queen of Peace also provides community benefit health activities at less than or at no cost to support those in the area serviced. These activities include community education programs, special programs for the elderly, handicapped, and medically underserved, and a variety of broad community support activities. During the year ended June 30, 2009, specific activities include meals delivered to residential homes, meeting facilities, programs for patients and families suffering from cancer, diabetes, breathing disorders, and others, assistance to health educators, emergency healthcare providers, wellness programs, and overnight housing for families of hospitalized patients. As a member of the Avera Health network, Avera Queen of Peace upholds the vision of the Presentation and Benedictine Sisters to work through collaboration to provide a quality, effective health ministry and to improve the health care of individuals and our communities through a regionally integrated network of persons and institutions. Avera Queen of Peace engages in activities designed to improve the health of individuals and communities in response to a calling to heal the sick, the elderly, and the oppressed.
