Avera St. Benedict Health Center (Center) operates a 25-bed critical access, acute care hospital, a 47-bed nursing home, a 28-bed assisted living center and rural health clinics located in Parkston, Tripp and Lake Andes, South Dakota. The Center provides acute care and long-term healthcare services. Amounts and types of services provided during the year ended June 30, 2009 were: 1,176 hospital patient days, 1,463 swingbed days, 87 nursery patient days, 16,815 nursing home resident days, and 9,239 supervised living days. The Center’s three clinics completed a total of 20,995 primary care visits to the people of their community. The Center maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges forgone for services and supplies furnished under its charity care policy and equivalent service statistics. These amounts do not include those services that are provided to patients and residents covered by Medicare, Medicaid, state agencies, county, and other third-party payors where less than full charges are received. The amounts of charges forgone, based on established rates, were \$145,489 and \$102,733 for the years ended June 30, 2009 and 2008.
