years ago, when people, including youth, in a mental crisis were taken to jail until they could be assessed and either transferred to a behavioral health center or released The Healthy Community/Healthy Youth Coalition determined the need for a safe, humane, and caring 24-hour crisis room Funding comes from insurance programs, Hughes County, and the Community Benefit program of St Mary's Healthcare Center This room helps keep over 100 people safe each year, with ages starting at 7 years old and stretching to over 80 years old Traditional Charity Care, unpaid costs of Medicaid, The Target population for this program is the elderly and frail The identified community need is to improve the health of elderly people Health conditions are uncovered earlier for those who participate in these programs For instance, an elderly diabetic might save a limb through early detection with this program Prenatal Classes - This program Targets young parents We are the only provider in the area that provides this service Several different agencies collaborate in developing the programs and in monitoring outcomes As a result of this program, the target population HAS become more ready for the birthing experience and has healthier babies Infant Car Seat purchases - This program Targets new borns The unmet community health need stems from a significant percentage of the local population being either unaware or financially unable to meet the safety needs of new born auto passengers Other agencies provide some of the resources needed to make this program successful but St Mary's is needed to complete the program objectives No child leaves the event without a safe care seat installed properly in the vehicle Support Groups (Alzheimer's, Food Allergy, Bereavement, Chronic Pain, Steven's Ministry, and Senior Citizens) - The Fair Market Value of the gift was \$130,000. We are pleased to report that the campus is now open in 2009. CUC provides education for healthcare workers and St Mary's has had a long history of supporting this important community resource. Students receive clinical experience on the St Mary's hospital campus. Girls in Science Fair - This program Targets high school girls. MANY OF WHOM are not exposed to a curriculum that would lead to health careers. The need to develop a program to introduce health care services to local students was uncovered by local schools, teachers and parents. The outcome has been an increased enrollment in the sciences. St Mary's provides instructors and role models for these young aspiring talents. The audience is made aware of career choices. Half of the participants are Native American. Student internships and clinical training for the University of South Dakota - Staff at St Mary's gives a large amount of time to students. Our hospital provides the clinical setting and staff to provide the educational experiences these students need to complete their training. This vital activity provided the real life experience that is so needed for students to be successful in their careers. The local community benefits because many students aim to come back to the Pierre area to work after school. Health Occupations Class presentations- This program targets junior and senior level high school students in the local community and encourages more young people consider health careers. The impact has been an increase in the number of youths to join health careers as demonstrated through regular surveys of participants. Students have the opportunity to shadow St Mary's employees in real life settings. St Mary's donates space and presenters for the classes. The program provides enough training to take a test and become a Certified Nurse's Aid and many students have done so and started their careers in healthcare.
