Children’s Care Hospital and School, with locations in Sioux Falls and Rapid City, SD, treated an estimated 2,148 children with special needs last fiscal year from South Dakota and twelve other states. Outpatient and outreach programs delivered 29,813 and 80,185 15-minute units of service, respectively. The average daily census for inpatients was 76.3 and for day students was 38.5. The four largest program services, Behavioral, Educational, Rehabilitation, and Medical, are delivered through outreach, outpatient, and inpatient programs. To better serve the growing demand for behavioral services, Children’s Care created a treatment team of professionals in early 2007 to work exclusively with children with Autism or other behavioral challenges. A second team was created to work with children with multiple disabilities. Both teams include teachers, psychologists, nurses, physical, occupational, and speech therapists, and social workers, all working together for the best interests of the child. Children’s Care has three of the state’s four Board Certified Behavior Analysts (BCBA), and all staff on the behavioral team have received training in Applied Behavior Analysis, an evidence-based treatment for children with Autism and other behavioral challenges. Children from 88 school districts are served, with staff providing either direct care or consultations. The TEAM (Tone Evaluation and Management) clinic for children with Cerebral Palsy, led by two physicians, recently received satisfaction survey results of 99%. Two studies on best practices for children with developmental disabilities were conducted at Children’s Care in the past year, also led by a physician. Additional services include in-home behavioral therapy with therapists treating children in their homes so they can be integrated into the school district. Early intervention and intensive therapy give positive results.
