Radio ProgramBack to the Bible is a 25-minute radio program where listeners and viewers become part of a personal Bible study with Dr. Woodrow Kroll as the leader. Each weekday, Dr. Kroll helps listeners and viewers get a solid grasp of biblical principles and to find ways to apply them to real life. The program was aired on an average of 1,180 terrestrial radio outlets across the U.S. during the fiscal year. A 28-minute television version is provided through the Web and on select television outlets. The Bible Minute provides biblical insight for everyday life. Each Bible Minute topic has an accompanying Bible Study, giving participants an opportunity to engage God’s Word in a meaningful, practical way. Primary distribution is radio with e-mail and RSS formats available at BibleMinute.org. Literature and Media ProductsCDs, DVDs, and printed studies and devotionals provide Bible teaching and engagement items for sale or at no direct cost to individuals around the world. Nearly 1.0 million items helped people win the day spiritually just in the U.S. InternetThe Web sites provided additional materials for those involved in the various audio and video ministries of The Good News Broadcasting Association, Inc. Over 1.7 million unique visitors made use of sponsored Web sites last year.

Through 12 global locations, listeners and viewers in 85 countries have the opportunity to receive Bible teaching, discipleship and Gospel outreach in a language that is meaningful to them.

Youth OutreachPowered by 4 coaches, users through daily Bible engagement. Personal blogs and other resources are used to encourage site visitors to take in God’s Word. Research with over 50,000 participants across the U.S. and other international locations proves that engaging with God through His Word four or more times per week provides a distinct power for living. 411God is a Bible portion provided daily by text or voice message to cell phones designed for the person who rarely engages the Bible in a given week. Partnership with Youth for Christ, the American Bible Society and local churches has grown the beta test market. Initial findings with respondents (ages 10 to over 50) are that only 3.6 percent did not plan to continue with 411God - revealing significant interest in this daily Scripture engagement methodology.
