The Suburban Hospital Foundation underwrote the activities of Suburban Hospital's Casey Center for Diagnostic Cardiology and Diabetes Education, which includes the activities of the Hospital's popular Cardiac Rehabilitation program Cardiac rehab enrolls 400 patients every week, in three levels of activity Our multidisciplinary team of health professionals is dedicated to improving the quality of life for those recovering from a heart attack, heart surgery, or cardiovascular disease through cardiac rehabilitation through a structured program of education, exercise and peer support designed to guide lifestyle modification The funds from the Foundation ensure that the Center and its equipment is maintained and that staff are available with the proper continuing education credentials The Diabetes Education program is available to both inpatient and outpatient populations Diabetes educators are available for more than 60 inpatient consults monthly The educators, along with community physicians, also conduct monthly "Diabetes School" programs and individual consults for over 300 patients annually

The Suburban Hospital Foundation underwrote several initiatives within the Suburban Hospital Cancer Care Programs These included several support groups and cancer education events attended by thousands of people, such as "Check It Out" (4,200 attendees), Living After Cancer symposium (190), Prostate Cancer symposium (210), and Survivor Day (130) The Foundation also assisted in the provision of charity care by covering the costs of 252 mammograms and 22 ultrasound procedures for low-income women The salaries and benefits of two nurse navigators are funded by the Foundation These professionals are available to assist all patients with understanding their treatment options and coordinating care They have a special role in identifying cancer patients in need of assistance with insurance, transportation, rent & utilities, and child care during treatment Free screenings for community members for skin and prostate cancer were also provided to 323 people
