These excursions and travel experiences create specialized opportunities for persons with intellectual disabilities to participate in recreational and social activities that might not otherwise be available to them, thus broadening their horizons and providing respite for their families and caregivers. The recreational/travel service provides 24-hour supervision with staff and volunteers in each room or nearby for guests with increased independence.
