Annually the Foundation processes over 24,000 gifts from 16,000+ donors During the course of the year over 3,000 personal calls were made by development staff on individual major gift donors This is in addition to the thousands of contact and cultivations that are made at events held on and off campus during the year The Foundation publishes an annual report that goes to donors, alumni, and friends of the School of Medicine and University Hospitals plus three issues of the Medical Bulletin packed with timely articles on research projects, advances in medical care and global projects that involve the School of Medicine These pieces serve to inform our donors and also cultivate their continued interest in supporting their area or areas of interest The Foundation has a longstanding recognition society (Co-Founders) that recognizes and stewards donors who annually support medicine at the level of \$1,000 per year These donors receive invitations to fee lectures and other events at the school to help in the development process The Berryhill Society honors donors who have established any type of planned/deferred gift to benefit medicine The Medical Foundation website provides timely information on events, research, ongoing an new projects and programs in the School of Medicine as well as providing an easy way for donors to receive information on how to make a gift or any of our programs The Medical Foundation has the fiduciary responsibility for administering over 1,100 separate funds composed of endowments, restricted and unrestricted funds These accounts provide key support for students, faculty, research, and patients The support these gift funds provide is essential to the continued medical excellence of the School of Medicine and University Hospitals at UNC Chapel Hill We are in regular contact with our account holders and provide them with monthly reports on gifts that have been credited to their accounts as well the current balances and activities in their funds
