SCHOLARSHIPS:

Scholarships do more than help students with tuition and book expenses. Many programs of study have special equipment, uniform and licensing costs that add to the total educational expense. The Foundation manages more than \$1.6 million in 78 scholarship funds to support TTC students. These awards, provided by individuals, businesses and other foundations are competitive and based on criteria established by the donors and the Foundation.

TUITION ASSISTANCE/CREDIT COURSE ASSISTANCE PROGRAMS:

To provide professional and personal growth opportunities for faculty and staff, the Trident Technical College Foundation will provide financial support, up to an annually budgeted amount, for full-time permanent employees to take credit courses.

Trident Technical College Tuition Assistance-Based on availability of funds, the Foundation will pay for tuition and required books for up to four semester credit hours per term in any TTC course for which an employee is qualified.

MINIGRANTS:

In 1991, TTC and the foundation established a minigrant program to provide funds to faculty and staff for equipment, materials and special resources. The program is designed to enhance the learning experience of TTC students while bridging the gap between instructional needs and departmental budgetary constraints. The annual allocation for minigrant awards totals \$50,000 for 2008-2009. Sources of financial support for the grants include the Foundation's annual campaign, TTC faculty and staff campus campaign and the college. Each minigrant has a limit \$1,200.
