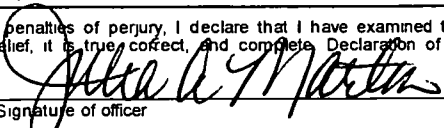

With respect to any person nominated to serve on the Board of Directors of the Institute pursuant to Section 4.1(iv), the Executive/Finance Committee of the Board of Trustees of the South Carolina Research Authority may, with or without cause, decline to appoint any such nominee, in which case the members of the Board of Directors of the Institute who are serving on the Board at that given time shall nominate another person for such Board position, with such nomination process continuing until a nominee is appointed.

Members of the Board shall be eligible to be appointed as officers of the Institute, and the President must be a member of the Board except in the case of an interim President appointed under Section 3.3(b). The Board of Trustees of the South Carolina Research Authority may remove any member of the Board of Directors appointed pursuant to Section 4.1(iii) at will, without cause and without notice. The Executive/Finance Committee of the Board of Trustees of the South Carolina Research Authority may remove any member of the Board of Directors appointed pursuant to Section 4.1(iv) at will, without cause and without notice.

4.3 Vacancy. Any vacancy occurring on the Board of Directors involving a Board position designated in Section 4.1(i) or (ii) shall be filled, as noted in Section 3.3 above, by the appointment by the Chairman of the Board of Trustees of the South Carolina Research Authority of an interim successor to fill such Board position. Any such interim successor shall

serve on the Board of Directors until the successor Chief Executive Officer or Chief Financial and Administrative Officer

Any vacancy occurring on the Board of Directors involving a Board position designated in Section 4.1(iii) shall be filled immediately upon the action of the Board of Trustees of the South Carolina Research Authority appointing a successor to fill the unexpired term.

Any vacancy occurring on the Board of Directors involving a Board position designated in Section 4.1(iv) shall be filled by the appointment by the Executive/Finance Committee of the Board of Trustees of the South Carolina Research Authority, based upon the nomination by the affirmative vote of a majority of the members of the Board of Directors of the Institute who are serving on the Board at that given time, of a successor to fill the unexpired term. With respect to any person nominated by the board of Directors to fill a vacancy on the Board involving a Board position designated in Section 4.1(iv), the Executive/Finance Committee of the Board of Trustees of the South Carolina Research Authority may, with or without cause, decline to appoint any such nominee, in which case the members of the Board of Directors of the Institute who are serving on the Board at that given time shall nominate another person for such Board position, with such nomination process continuing until a nominee is appointed.
