Instruction-Rabun Gap-Nacoochee School is a 105 year old independent boarding and day school providing co- education college-preparatory in grades six through twelve that has a covenant relationship with the Presbyterian Church Rabun Gap-Nachoochee School (RGNS) educated 339 students from 13 countries and 15 states for the current fiscal year with an average class size of 11 The middle school had an enrollment of 85 boys and girls International students comprise approximately 20 percent of the student body The faculty averages 15 years of teaching experience, with an average of 8 years at RGNS Of the 54 classroom teachers and 17 residential faculty, 75 percent hold graduate degrees or higher Advanced Placement (AP) courses offered in all academic departments with 28 percent enrolled in an AP course and 75 percent of AP candidates received a score of 3 or greater making them eligible to receive college credit for their work The class of 2008 earned SAT (2400) scores of 1691 for 58 students With 24 clubs and student organization, students participate in a wide range of activities The international students have a diverse range of activities that include all types of generational contribution
