Instructional and Student Activities Approximately 2,080 students are enrolled from pre-kindergarten through 12th grade. Pre-K pupil ratio is 1 to 15, Grade K is 1 to 16, Grade 1 is 1 to 19, Grades 2 through 6 is 1 to 20, and Grades 7 through 12 is 1 to 12. Promotes spiritual, personal, athletic, and social development in addition to meeting the academic needs of its students with a planned program of excellence from pre-kindergarten through 12th grade. Lake Highland seeks to provide a comprehensive, enriching education that will enable students to continue their academic studies successfully at the college level. These goals are achieved through a diversified curriculum, small class size, and personalized instruction by a staff of fully certified teachers.

Auxiliary Activities and Student Transportation Auxiliary activities include the athletic department, admissions testing, and yearbook production and sales. The Organization also transports approximately 80 students from door to door in 7 vans - 10 to 14 students per van. Safety record is excellent. Vans are also used for field trips and athletic events.
