 Pre-School Care South County Family YMCA operates two pre-schools in the Venice community, providing full-day care from 7 00 a m - 6 00 p m We provide safe, loving, affordable care for over 200 children ages six weeks - five years In 2009, we discounted our rates to assist needy families in our pre-schools by over \$153,000 These funds are obtained through our special events and annual giving campaigns and are also subsidized through membership fees Currently, over 50% of the families enrolled in the pre-schools participate at a subsidized rate through YMCA scholarship assistance or through funding from the Early Learning Coalition Approximately 60% of our participants are currently living at or below the federal poverty level Both pre-schools are licensed through the Department of Children and Families, which ensures that the centers adhere to strict guidelines that improve the quality of care that is provided The Venice pre-school is Apple Accredited, which is one of the highest ratings a center can receive Both sites have contracted with the Early Learning Coalition and with the state of Florida's Voluntary Pre-Kindergarten Program

**4b** (Code ) (Expenses \$ 1,505,793 including grants of \$ 36,387 ) (Revenue \$ 1,402,165 )  
 School Age Care South County Family YMCA's school age care program provides before- and after-school care for youth from kindergarten through eighth grade The program is available at six sites, including two YMCA branches, three schools, and one church Before-school care begins at 6 30 a m , and after-school care ends at 6 00 p m For students at which we do not offer the program at their school, the youth are bussed to the YMCA During the school year, approximately 450 students participate in school age care Daily activities available include learning centers, homework help and tutoring, arts and crafts, group games, and physical fitness The YMCA also has two YMCA READS! sites offered through school age care This program provides free extensive reading tutoring from trained staff and volunteers in a one-on-one setting for students from kindergarten through third grade Our sites have been ranked first and third in the state by evaluators hired by the Department of Education Full-day school age programs are also offered to youth throughout the year when school is not in session The programs are available from 7 00 a m - 6 00 p m and were attended by almost 600 children this year In FY 2009, the YMCA provided discounted rates of over \$146,000 to needy families in the school age program The program is licensed through the Department of Children and Families

 Sports In 2009, over 1,800 kids participated in South County Family YMCA's sports programs Sports leagues are offered to children ages three years - eighteen years in soccer, basketball, tee-ball, baseball, and volleyball The "Y Winners" philosophy is utilized, which ensures equal playing time for all children, regardless of their skill level Aquatics and gymnastics are two of our other sports departments Programs and classes are offered in these sports in competitive and non-competitive environments In 2009, over 500 kids learned to swim in our aquatics program The competitive swim team currently has about 80 participants The gymnastics department offers instruction in dance, cheerleading, and gymnastics to kids from pre-school age to teenagers Scholarship assistance totaling over \$36,000 was provided to participants in sports programs in 2009
